- Debbie Timby has selected some new trees and shrubs for planting.
- Motion detector lights will be installed on the Rectory.

There are several, more costly projects that are being looked at for 2022. George is putting together a list so that if people are so inspired to donate money for these projects, they know what is needed.

Diocesan Solar Project

Dave B. has been attending the meetings discussing this opportunity and after describing the overall project and our possible participation in it, made the following motion

I make a motion that we sign the Letter of Intent for the Episcopal Camp RI Solar project, with the selection of the zero-cost option, which affords us a projected savings of 20%.

The motion was seconded by George L. and passed unanimously.

David B. and Chris B., will review all participation options over the summer and make the final decision as to what level of support we can afford in time to make a final commitment, sometime in the 4^{th} quarter. The length of commitment is 25 years.
