*As a Vestry, we've already done some of these actions -

"select a challenge facing your church" – we've selected the very vital issue of regathering "consider it in the context of the faith community's vision" – regathering is taking place in the context of "Criteria for Regathering Parish Ministries."

*The next issue that the book mentions, and that we need to address, is communicating with the members of the Parish.

* Peter made the point that all of the above should be done within the context of *Invite, Welcome, Connect* – which is the process we adopted and began before the pandemic, and which has the potential of being transformative for our church.

The Vestry – especially the newer members – would like the "Cliff Notes" version of what *Invite, Welcome, Connect* is.

David was prepared to give a more detailed budget and financial presentation, but then noticed that the next chapter in the Vestry Handbook is on finances – so he thought it would be more appropriate to delay his in-depth presentation until next month. His brief presentation at this meeting was essentially "so far, so good."

Junior Warden Update – George LeBlanc

George had sent out a complete report and highlighted the following items:

- Final invoices for the 2 furnaces received and processed. Warranties processed. \$6346.
- Washing the Parish House, by volunteers, is in process. We are about 80% complete.
- The driveway coating has been completed, and looks really good.
- Planting around the electrical boxes, the Rectory and other assorted places is well in hand.

George is gathering a list of projects for 2022. We might want to publish this list at some time, in case anyone wants to donate money to help complete these projects?
