### **TREASURER'S REPORT June 2018 Vestry Meeting**

### **Budget Discussion Points:**

 Two line items of interest (Budget vs. Actual YTD)– Facilities Use income –\$4k, and Personnel Costs \$-12k. Though it is a bit unclear due to the Montessori issues at hand, Facilities Use appears to be a case of over-budgeting by perhaps \$7,000 this year. I will clarify this for next meeting. Most of the Personnel Costs issue relates to timing of retirement plan/housing equity payments, and should work its way out over time Most of the other items that show up as overages represent timing issues that should come back in line over time.

### **Endowment Update: (Van Liew Only)**

Gain/(loss) May 2018: \$51,392 less \$24,250 draw less \$5 restrictions released moved to operating account = \$27,137 net increase Gain/(loss) YTD (2018): \$32,149 less \$153,563 draws and fees = -\$121,414 net decrease Balance at 05/30/2018: \$3,703,339

### **Other Items:**

- 1) We have agreed to provide Lay employees with short & long-term disability insurance through Church Pension Group. The short-term will be paid by SM (approx. \$200-400 per year per employee, depending on salary level), and the long-term will be optional and paid by the employee if elected.
- We are applying for a corporate credit card with Bank Newport I am asking for a \$5,000 credit limit. The version we are applying for does not require a personal guarantee by an individual.
- 3) Elizabeth Dellenbaugh, the lead investment person on our account with Van Liew Capital has decided to leave the firm. Her partner Joe Healey will be taking over as lead advisor and a new person (James M. Powell) will be assigned to the account under him. I do not expect this will have a material effect on how our account is managed.
